INFORMATION SHEET ON SCHOOL BUS SERVICES FOR YEAR 2017

Introduction

Currently, the school appoints one or more school bus operators to help parents make transport arrangement for their children. The school will invite proposals from operators registered with the Government Electronic Business Centre (Gebiz) and select the operators who can deliver the services required and have submitted the most competitive prices in term of base fare. Parents will then engage the appointed bus operators to agree on the actual bus fare, taking into account the distance, route and other factors such as the seating capacity of the bus. The contract period is normally about 2-3 years. When the contract expires, the school will go through the procurement process again.

Enhanced Process

2. We have enhanced the process under the MOE School Bus Service Pilot Project which will take effect from January 2017 as follows:
 - a. The school will extend the invitation for proposals for bus services to all interested bus operators so as to attract more competitive offers. To achieve this, the school will advertise the invitation at the Information Notice Board for School Bus Services (IBSB) website developed by MOE HQ.
 - b. Interested bus operators will be required to submit the 'Not-To-Exceed' (i.e. the maximum) fare for each distance benchmark (i.e. 2km, 4km and 6km). These fares will help parents negotiate with the appointed school bus operators, if there is a need to do so. The bus fares will not go beyond the NTE during the service period. For students staying beyond the maximum distance range, parents will negotiate fares with the bus operator.
 - c. The annual bus fares will be payable over 9 months in a school academic year. The collection months are January, February, March, April, May, July, August, September and October. There will be no collections for the months of June, November and December. Please refer to the illustration in Appendix A.
 - d. The school will publish the fares quoted by the appointed bus operators in the IBSB website at <https://schadmsvc.moe.gov.sg/moeibsb/> for viewing by parents. Parents can also access the IBSB website through the 'Info for School Bus Services' button in MOE Internet Homepage (at <http://www.moe.gov.sg/>).

3. We are pleased to inform you that the school has appointed Bedok Transport Pte Ltd for the period of two (2) years from 1 Jan 2017 to 31 Dec 2019 to provide the following services:

- a. Daily School Bus Services (i.e. for sending pupils from home to school and vice versa); and
- b. Bus Services for after school activities (i.e. sending pupils home from school after enrichment programmes, supplementary classes or CCA).

4. Parents who are interested in taking up the school bus services in 2017, please complete the attached request form and forward it to the bus operator or the General Office directly by **15 Nov 2016**.

School Bus Fares

5. Parents may discuss their requirements directly with the bus operators to agree on the actual bus fares based on the 'Not to Exceed' Price.

6. The tables below show the 'Not to Exceed' Prices for both the daily school bus services and services for after school activities:

- A. Daily School Bus Services (i.e. for sending pupils from home to school and vice versa) and for after school activities (i.e. sending pupils home from school after supplementary lessons / enrichment programmes and CCA)

Note 1: Charges for small buses (15 and below seater type) are generally higher for the host of benefits of mandatory installation of seat belts, one-to-one seating, easier access to pick up points and shorter journey time.

Note 2: Bus Services for after school activities will be applicable only for Tampines and Simei areas

7. For students staying beyond the maximum distance range, parents may approach the bus operator directly for negotiation of bus fares.

Other Information

8. We would like to highlight the following:
- a. The school bus service is provided for trips to and from the school before and after official school hours as follows:
 - i. Daily school timing: 7:45am to 1:45pm (Mon – Thu);
7:45am to 12:45pm (Fri)
 - ii. Latest arrival time in school: 7:00am
 - iii. Latest departure time from school: 1:55pm (Mon – Thu);
12:55pm (Fri);
3:45pm (after school activities on
Mon, Tue, Wed, Fri)
 - b. It is the parent's responsibility to pay the monthly bus fare directly to the bus operator by cash / cheque.
 - c. The annual bus fares will be collected over 9 months in January, February, March, April, May, July, August, September and October. There will be no collections for the months of June, November and December. School services will still be provided on every school day in the months of June, November and December.
 - d. Parents are advised to take note of the operator's termination clause.

Feedback

9. The school will continue to seek feedback from parents periodically. Parents may also provide feedback directly to the school. The information gathered will help the school in assessing the appointed bus operators' performance and decide whether to renew their contracts or go through the proposal invitation process to appoint new operators.

Payments are spread equally over 9 months

Benefits of 9-month payment schedule:

- No advance payment is required for the month of Dec, Jun and Nov.
- Bus fare is paid over 9 equal payments.
- Pay as use basis.
